1. INKCAZO YOMSEBENZI WE-OPFA / IINKONZO EZINIKIWEYO

IOfisi yoMlamlili weeNgxowamali zoMhlalaphantsi (Office of the Pension Funds Adjudicator) (“OPFA”) ngugunyaziwe osemthethweni osekwe ngokweCandelo 30B lomThetho weeNgxowamali zoMhlalaphantsi, wama-24 ka-1956 (Pension Funds Act, 24 of 1956). Injongo engundoqo yoMlamlili kukwenza izigqibo ngezikhalazo ezinxulumene nengxowamali ezifakwe ngokwecandelo lama-30A(3) lomThetho weeNgxowamali zoMhlalaphantsi, kunye nezikhalazo ezo uMlamlili onyulelwé zona ngokwecandelo lama-211 lomThetho woLawulo IweCandelo lezeMali, 2017 (Financial Sector Regulation Act, 2017), ngendlela ehamba ngenkqubo efanelekileyo, enoqoqosho kwaye ekhawulezayo. I-OPFA liziko likarhulumente leShedyuli ye-3A njengoko kubhekiselwe kulo kumThetho woLawulo IweMali kaRhulumente, ka-1999 (Public Finance Management Act, of 1999).



ICandelo lama-30L lomThetho weeNgxowamali zoMhlalaphantsi libonelela ngokuba:

30L. Irekhodi leenkqubo. —(1) UMLamli uya kugcina okanye enze ukuba kugcinwe, nokuba kungokubhaliweyo okanye ngendlela yobuchwephesho okanye ye-eletroniki, irekhodi elisisigxina leenkqubo ezinxulumene nesiggibo ngesikhala zo kunye nobungqina obunikiweyo.

(2) Naliphi na ilungu loluntu linokufumana ikopi efundekayo yerekhodi yentlawulo yemali ehlawulwayo emiselwe nguMlamli.

Ngokufanelekileyo, unokucela ikopi efundekayo yerekhodi yeenkqubo ezinxulumene nesiggibo kwisikhala zo ngaphandle kwesicelo se-PAIA.

I-OPFA inokulwala ufiikelelo ukukhusela abanye

Ngokwe-PAIA i-OPFA ivumelekile ukuba ilwale ufiikelelo kumaxwebhu athile. Imihlaba yokwala kukukhusela –

- ubucala bomnye umntu;
- ulwazi lorhwebo lwenye inkampani;
- ulwazi oluyimfihlo lomnye umntu;
- ukhuselo lomntu kunye nepropati;
- iirekhodi ezivela ekuveliseni kwiinkqubo zomthetho; kunye
- nolwazi lophando.

Uya kwaziswa ngokubhalwe phantsi ukuba ingaba isicelo sakho sivuniwe okanye sikhattyiwe na kwiintsuku ezingama-30 zekhalenda emva kokuba sifumene iFom yeSicelo soFikelelo egcwalisiweyo. Ukuba ngaba naliphi irekhodi le-OPFA elicelwe nguwe alifumaneki okanye alikho, i-OPFA, ngendlela yengxelo efunzelwego, iza kukwazisa ukuba ngeke kwenzeke ukufikelela kwelo rekhodi.

9. UKUSEBENZA NGOLWAZI LOBUQU

Ngokwe-POPIA i-OPFA kufuneka ichaze ngokweenkukacha ukuba iza kusebenza kwaye iloluphi ulwazi eza kusebenza ngalo. linkcukacha zoku zifumaneka kwiwebhusayithi ye-OPFA phantsi koMgaqonkqubo wewebhusayithi ye-POPIA.

I-OPFA ayicebi kudlulisela lwazi lobuqu ngaphaya kwemida yase-SA, kodwa inokukwenza oko ukufumana kunye nokuxhasa idatha, okanye ngezizathu zobuchwepheshe. Uhlobo lwe-cloud computing luthetha ukuba idatha ethile inokudlulisela ngaphaya kwemida. Apho kukulawulo lwe-OPFA, iza kudlulisela kuperha idatha kwamanye amazwe anemithetho yobucala nokhuselo lwedatha efanayo neyawo.

Ilukhusela njani ulwazi lobuqu i-OPFA?

I-OPFA izibophelele ekuqinisekiseni ukuba ulwazi lwakho lukhuselwe kwaye yamkele imigaqonkqubo ngokubhekisele ekuhlangabezaneni nale njongo. Ukuthintela

ufikelelo okanye ukuxelwa okungagunyaziswanga siye senza kwasebenza iinkqubo ngqo, eze-eletroniki nezolawulo ukukhusela kanye nokugcina ulwazi esiluqokelelayo.

linkonzo ezisebenzisayo i-OPFA zisebenzisa ubuchwepheshe obukhuselekileyo bokuhanjisa kanye nokugcinwa kwedatha ukukhusela ngokufanelekileyo ulwazi lwakho lobuqu ekubeni luxelwe ngokungagunyaziswanga kanye nokugcina ingqibelelo yolwazi lwakho lobuqu.

10. UNCEDO OLUFUMANEKAYO XA I-OPFA ISALA ISICELO SOLWAZI

10.1 UNCEDO LWANGAPHAKATHI

Ke ngoko, isigqibo esenziwe ngumNtu oNika uluNtu uLwazi sesokuggjibela, kwaye abantu abacela ulwazi okanye amaqela esithathu kuza kufuneka basebenzise uncedo lwangaphandle olunjalo abanalo ukuba ngaba saliwe isicelo solwazi, kwaye umntu ocela ulwazi okanye iqela lesithathu alonelisekanga yimpendulo enikwe ngumNtu oNika uluNtu uLwazi.

10.2 UNCEDO LWANGAPHANDLE

Ngokwecandelo lama-77A(2) le-PAIA, umntu ocela ulwazi okanye nawuphi umntu onesikhala zo unokufaka isikhala zo ngokubhekisele kwisigqibo somNtu oNika uluNtu uLwazi kuMlawuli oBeka iLiso aze aNyanzele ukuThobela kwiintsuku ezili-180 zokufumana isigqibo ngendlela nohlobo olumiselweyo ngoncedo olufanelekileyo.

Ukuba ngaba i-OPFA iyasilela ukuthobela amagatya e-PAIA, umntu ocela ulwazi okanye nawuphi umntu onesikhala zo, ngokungqinelana necandelo lama-78 le-PAIA kanye nomThetho woKhuthazo lokuGcina imiThetho wesi-3 ka-2000 (PAJA), unokuya eNkundleni enolawulo ngoncedo olufanelekileyo.

Ukuba umceli wolwazi okanye iqela lesithathu alonwabanga ngesigqibo soMlawuli oBeka iLiso aze aNyanzele ukuThobela ngendlela yokufaka isicelo kanye nakwintsuku ezili-180, linokufaka isicelo enkundleni ngoncedo olufanelekileyo ngokwecandelo lama-82 le-PAIA.
